MEMO TO: All Preston Woods Property Owners

SUBJECT: Architectural Committee Permanent Extension of Approvals for Alternate Roofing

Dear Preston Woods Property Owners:

The Preston Woods Deed of Dedication and Restrictive Covenants Section III Paragraph J states:

ROOFING MATERIALS. ROOFS SHALL BE COMPOSITION SHINGLE ROOF – HERITAGE II PROVIDED HOWEVER, IF FEDERAL, STATE, OR LOCAL LAWS PROHIBIT SUCH ROOFING OR SUBSTANTIALLY IMPAIR THE ENFORCEMENT OF THIS RESTRICTION, THE ARCHITECTURAL COMMITTEE MAY APPROVE FOR THE SUBDIVISION, SPECIFICATIONS FOR ALTERNATIVE ROOFING THAT IS HEAVY DUTY ORGANIC OR INORGANIC COMPOSITION SHINGLE AND WHICH SIMULATES A "WEATHERED WOOD" LOOK.

The Tamko Heritage II (25-year shingle) as specified in our covenants has been discontinued and replaced with the Tamko Heritage 30 shingle. Please be advised that the Preston Woods Architectural Committee approves the use of the following alternate roofing materials by any and all Preston Woods property owners:

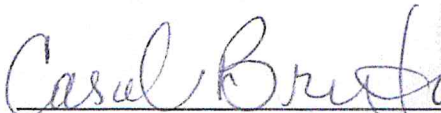
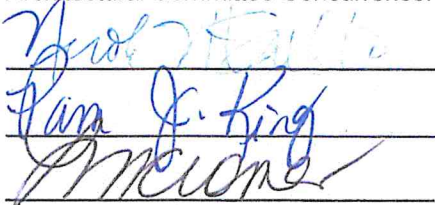
